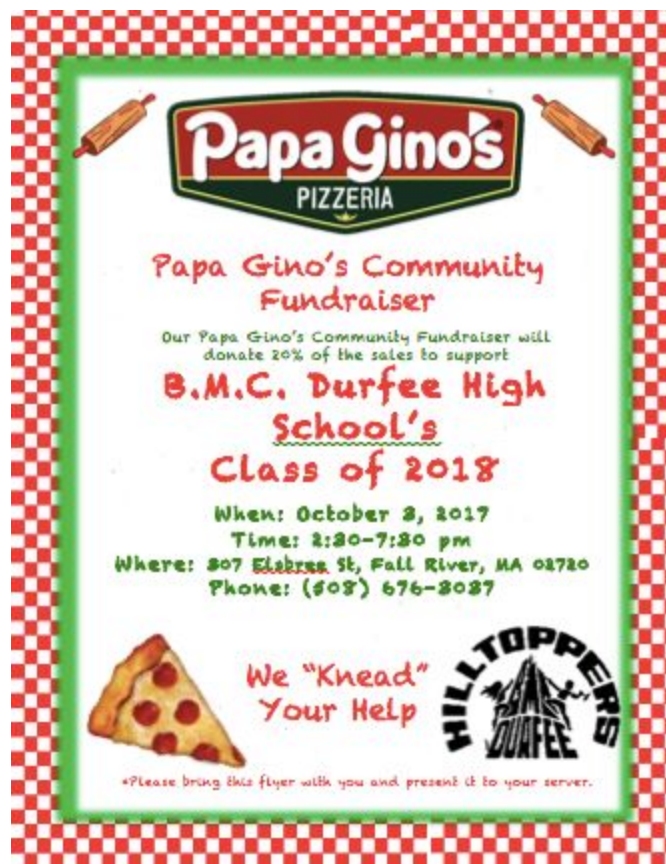
CLASS OF 2019 MEETINGS will be held every Thursday in Room 470. All are welcome!

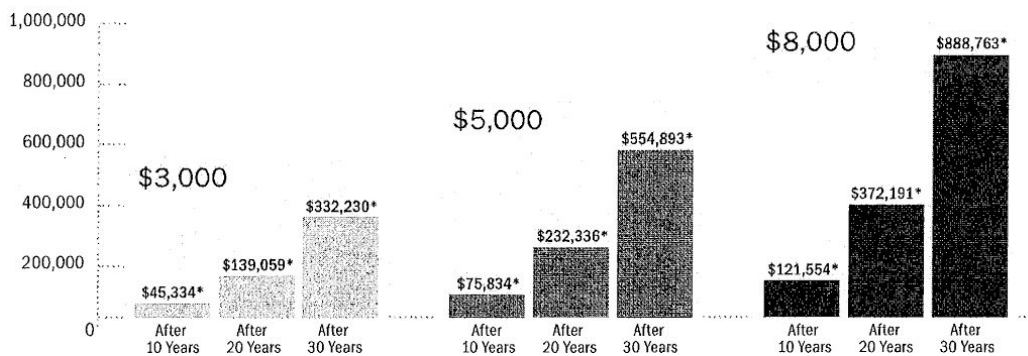
