If, for whatever reason, the requested topic is not placed on the Agenda of the School Committee Regular Meeting, any School Committee Member may move under New Business that the requested Agenda topic be placed on the Agenda of the next meeting of the School Committee. If the requested topic must be acted upon prior to the next scheduled School Committee Regular Meeting, then any School Committee Member may introduce the topic under New Business for discussion and/or vote.
